

Terms and Conditions

All membership conditions have been established to ensure the maximum enjoyment at Heffron Park Tennis Centre by all members and patrons. On acceptance by Heffron Park Tennis Centre of this agreement you will be referred to as a 'Member' and have the usage rights and obligations as detailed below and in the Club Conditions of Entry.

Membership Conditions

Your Membership commences on the date stated on the enrolmentagreement.

Your membership is personal to the individual and membership cannot be assigned or transferred to another person unless previouslyauthorised by the Club.

Up-front Annual Membership

- Your membership will not be refunded after your purchase for any reason
- · Annual membership cannot be put on hold

Recurring Monthly Membership

- A two week written notice (email) is required for cancellation and/or suspension of your membership before the payment date
- You may suspend your membership for up to two months a year
- Your membership will continue until you have requested its cancellation
- There are no refunds on any payments after the membership has been purchased unless we have failed to cancel your membership after two weeks written notice has been provided

Legally Binding Agreement

I understand that this agreement is legally binding whether my useof the facility and its services is determined and paid on monthly or annual basis.

I acknowledge that increases in periodic payments may occur and participants will be given a minimum of 14 days written notice prior to the increases being implemented.

Unavailability of Facility / Service

I agree to accept that a particular facility or service within the club premises may be unavailable at any particular time due to priorbooking, mechanical breakdown, fire, Act of God, condemnation, lossof lease, catastrophe, or any other reason. Further, I agree to not hold the club responsible or liable for such occurrences.

Commitment to Child Protection

Heffron Park Tennis Centre and its Operator will uphold practices that promote the safety, welfare and wellbeing of children and youngpeople. All participants and guests must behave responsibly.

Dress Code and Etiquette

I agree to abide by Heffron Park Tennis Centre's Dress Code as found on the website along with all etiquette guidelines.

Court Hire Conditions

Please note the following conditions and restrictions to members. Court Hire (Free)

- Available anytime between 7am and 5pm Monday to Friday
- Maximum time of 90 minutes per booking applies
- Limit of 2 free bookings per day
- No back to back bookings
- Member must be present on court at all times
- Zero external coaching permitted. If you coach/receive external coaching your membership will be immediately terminated and account suspended.

Court Hire (Other)

- \$22 per hour per court applies om Monday to Friday between5pm 10pm
- \$22 per hour per court at all times on Saturday and Sundays

\$5.25 guest fee for all non-members

Photography and Promotions

Release

I, and if being a minor my parent/s and guardian/s for and on behalf of myself, acknowledge that during all such times as I am on the premises of or included in any activity to the premises which is organised, approved or endorsed by Heffron Park Tennis Centre or its operator as an activity for me to take part in, both my property and person shall be at my own risk and I will not hold the Club or its Operator liable forany personal injury or loss of property which may arise from negligence of Heffron Park Tennis Centre, its Operator, its servants, agents, independent contractors, voluntary workers, other users of the facility or participants in the activities or spectators or other parties providing services through or in the facilities of Heffron Park Tennis Centre. I also warrant that I am physically fit and able to engage in exercise and fitness programs at the centre / facility.

I also give permission for medical / ambulance assistance in the case of an emergency and agree to pay such costs incurred.
